CONDITIONS OF MEMBERSHIP

I/We hereby apply for acceptance as a member of the Fort Lytton Motocross club Inc. (FLMC) and permission to enter and be upon property which the FLMC allows motorcycle riding and usage of the FLMC facilities. Upon being accepted as a member of the FLMC, I/We agree to abide and be bound by the terms and conditions, rules and regulations as determined by "FLMC" and the "AMA Clubs" in respect of my/our being involved with the members or property of FLMC and that:

- I/We will carry out any reasonable instruction given to me/us by any committee member of FLMC or staff and will in a like manner refrain from performing anything which may be forbidden by any committee member.
- I/We will not attempt to ride a motorbike on the grounds without first notifying FLMC and acknowledge the right of FLMC to refuse permission to ride on the property, or for any other cause, without my/our having signed an indemnity in such form as FLMC may from time to time require.
- I/We will not permit any other person to ride a motorbike on the property unless that person has also signed an Indemnity form indemnifying FLMC against all claims and actions.
- I/We will exercise due and reasonable care at all times when riding on the property and understand that careless and dangerous riding will automatically result in the offender being removed from the property.
- I/We will abide by the terms set out in the club constitution, sign on sheet and conditions of entry.
- I/We agree to allow FLMC to use pictures of me, which are taken at a FLMC activity.
- I/We agree to follow and abide by the rules of the "AMA Clubs".
- When I/we ride at a venue managed by the FLMC I/We agree to be a current member of AMA clubs.
- I allow FLMC and 3rd parties associated with FLMC to contact me either when I'm a member or not.
- I/We will wear an approved Safety Helmet and other suitable protective gear as maybe recommended by FLMC while the motorbike is in use at a FLMC facility.
- I/We acknowledge that FLMC reserves the right to terminate this membership for actions which are likely to cause prejudice to FLMC.

INDEMNITY DETAILS

Motorcycling riding is dangerous and can lead to death to person & property, injury, damage and loss. I/We together with my/our executors, administrators and successors, in consideration of my/our being permitted to enter, be upon and use the property of FLMC, acknowledge that I/We am/are fully responsible for my/own safety and for any damage that may be done to my/our person or property, or any other person or their property as a result of my/our actions while at a FLMC venue. I/We hereby release the members and people who constitute FLMC from all claims at Law that may be made by me/us against FLMC for any grounds whatsoever and I/We hereby indemnify FLMC, the Port of Brisbane Authority, Main Roads, Land owners, the sponsors and their servants, agents and officials against:

- All claims of liability for any damage, loss, injury or death I/We may suffer in any way;
- Actions, which may be brought by anybody claiming through me/us. If I/We participate in the activities of FLMC I/We do so at my/our own risk and responsibility and I/We accept the condition of the grounds as it stands, with all or any defects, hidden or otherwise, and in full knowledge that participation can be dangerous to life person(s) and property.

Where more than one person signs this indemnity, we are bound each of us separately and all of us jointly by the conditions contained therein. Where the rider is a junior, the parent/guardian, on behalf of the junior rider(s), hereby indemnifies the parties indemnified above against all or any claim or liability for death, damage, loss or injury that the junior rider may suffer/cause as a result of participation in FLMC activities.
